#### b. Bonni Jensen, Board Counsel

- i. SB980/HB 1363 Memorandum dated January 23, 2018 (see attached) Ms. Jensen informed that SB 980 amends the minimum requirements in part VII of Chapter 112, which governs the actuarial soundness of defined benefit pensions. Additionally, SB 980 amends Chapter 121 by imposing many of the same requirements on FRS. SB 980 is consistent, to the extent that it imposes the same requirements on all defined benefit plans in Florida. For example, Reporting of Assets Values on a Market and Actuarial Value, New Schedule of pre and post retirement benefits, Process for Setting Investment Return Assumptions, Deletion of Existing Longstanding Requirements, 30 Year Amortization, Payroll Growth Assumption, Plan Sponsor Revenue Projections and Corresponding FRS Requirements. (Note: Current status, with more than half of the legislative session completed, the bill has not had a hearing and might not happened.)
- ii. Earkis Hill (lawsuit) Ms. Jensen informed that the City had been dismissed, and the pension board legal was successful in convincing Ms. Hill's attorney that there would be no gain for her to sue the Pension Board because there would be a request for a refund of legal fees, etc.

iii. 2018 IRS Mileage Rate Memorandum dated January 2018 – The IRS released its updated Standard Mileage Rate for 2018. The new rate is 54.5 cents per mile for miles driven after January 1, 2018. This is up 1 cent from 2017.
