Final Selection of New Assistant City Manager

After concluding a nationwide recruitment effort that yielded nearly 90 applications since October, the Office of the City Manager is pleased to report that the selection process to appoint a new assistant city manager to replace Duncan Tavares successfully concluded earlier this week.

Mr. Jeffrey L. Oris brings to the City of Delray Beach over 24 years of local government experience. He currently serves as a municipal government consultant for North Palm Beach based PLACE Planning and Design, Inc., where he is responsible for leading a variety of special district operations, economic development, redevelopment, zoning, and grant administration functions. As referenced in the attached resume, since 2017 he has been involved in multiple projects with the City of Naples, Florida; the Naples Community Redevelopment Agency; the Westgate Community Redevelopment Agency (Palm Beach County); the Fort Myers Community Redevelopment Agency; and the Town of Melbourne Beach, Florida.

A native of Long Island, New York, Mr. Oris earned a Bachelor of Science in Labor Economics and Organizational Behavior from Cornell University, as well as a Master of Public Administration from Syracuse University's Maxwell School of Citizenship and Public Affairs. Previous professional experiences include executive leadership positions with the municipal governments of Margate, Florida and Martin County, Florida.

Mr. Oris will begin his new role with the City of Delray Beach on Monday, January 10th, and a public introduction will take place on January 11th, during the City Commission meeting.

I wish to once again offer my appreciation to Director of Human Resources Duane D'Andrea, Chief of Police Javaro Sims, Chief of Fire Rescue Keith Tomey, Director of Development Services Anthea Gianniotes, and Director of

<u>Updated Direction for Interim Daily Operations for the Old School Square Complex</u>

As city administration continues to review and evaluate opportunities for long-term external partnerships to support artistic, educational, and cultural activities and functions at the Old School Square (OSS) complex, please be advised that contingency planning and direction is being offered to consider interim contractual services to maintain continuity of operations.

As referenced in the attached electronic mail message from Director of Parks and Recreation Sam Metott, guidance to this effect includes ancillary support for the Cornell Art Museum, outdoor concerts and events, as well as hosting duties and responsibilities for The Fieldhouse at Old School Square.

An update to this effect will therefore be offered publicly during the January 4th City Commission meeting, to include commentary relative to monthly external contractual assignment structures as outlined, as well as ancillary opportunities to collaborate with organizations such as the Delray Beach Downtown Development Authority and the Greater Delray Beach Chamber of Commerce to advance event and programming opportunities at the OSS complex.

Ancillary Guidance to Support Tropic Isle Comprehensive Infrastructure Improvement Program

With direction currently underway to commission design services for roadway and utility infrastructure improvements that will ultimately benefit the Tropic Isle area of the community (to specifically include water, sewer, and stormwater utility related services), please be advised that the City of Delray Beach will soon resume community engagement activities to help inform residents of anticipated recommendations and outcomes.

Although efforts to this effect were initiated in 2019, details resulting from preliminary technical analysis and data gathering to outline the actual improvements to be implemented necessitate additional clarity for all concerned.

The Office of the City Manager and that of Director of Public Works Missie Barletto were informed earlier this week by the Florida Department of Environmental Protection that the Tropic Isle Improvements Project funding application is presently ranked 11th out of 76 submissions statewide. This has the potential to result in a significant allocation of funds which could help support our efforts as outlined. Specific updates and considerations will be made available publicly in the coming weeks.

Interlocal Agreement Considerations for Possible Joint Fire Rescue Training Services Involving the City of Boca Raton

A few weeks ago, my office hosted a meeting with leadership from the Boca Raton Office of the City Manager and the Boca Raton Fire Rescue Department to discuss the possibility of executing an interlocal agreement for joint fire rescue operations. The genesis of this consideration involves the fact that DBFR currently contracts with agencies located further away, including the City of Coral Springs, the Broward Fire Academy, and Palm Beach State College.

All involved are presently contemplating an agreement to enable DBFR to share training resources at the Boca Raton Fire Rescue Training Center, located at 800 Bayan Trail in Boca Raton.

The benefits to the City of Delray Beach include a convenient training location, which could represent a reduction in annual DBFR training costs, as well as alleviating concerns relative to recalling units that may have been assigned for training if an increase in call volume is experienced, and/or other emergencies occur.

Recommendations for City Commission review and consideration respectively are anticipated in the next few months. Meanwhile, agents of both municipalities continue to work to compile and review data and other pertinent information necessary to clearly identify and comprehend all the merits of this opportunity.
