Hazen and Sawyer Involvement to Support New Water Treatment Plant Contractor Selection Process

As the Department of Utilities continues to engage with engineering consulting firm Hazen and Sawyer for owner representation necessary to advance initiation of a new water treatment plant design-build contract selection process, please be advised that an industry forum event will take place next Wednesday, May 10th at the Swinton Operations Complex.

As noted in the attached flyer, this event will enable the City of Delray Beach to help publicly outline product details for companies and industry professionals interested in working with our organization. Respective discussions and presentations will include the project's background, procurement approach, project schedule, preliminary budget, and a tour of the existing facility.

Once this exercise concludes, tasks will be initiated to engage the Request for Qualifications processes. With preliminary technical documents and project data to be compiled by Hazen and Sawyer, said information will be updated into the City's procurement template for invitation outreach purposes.

Favorable Outcomes Involving Palm Beach County Office of the Inspector General Review of Accounts Payable Functions

Both the Office of the City Manager and that of Chief Financial Officer Hugh Dunkley are pleased to report that the City of Delray Beach recently received a declaration of implementation from the Palm Beach County Office of the Inspector General (OIG) relative to current accounts payable procedures, as well as applicable internal controls.

As referenced in attached electronic mail message from OIG Director of Audit Hilary Bojan, outcomes to this effect include implementation of specific processes for food and beverage purchases for resale at the Delray Beach Golf

Club; clarification regarding purchasing authorization levels for expenditures greater than \$65,000; adherence to updated petty cash policies; and implementation of updated purchasing card policies to enable periodic review for individual users.

Additionally, the City's charitable and benevolent contributions and special events funding policy was deemed to follow the recommendations of the OIG.

Operational leadership will continue to direct and advance the City of Delray Beach's established system of internal controls concerning these and all other pertinent matters.

Resilient Florida Grant Program Considerations to Help Support Public Safety Facility Improvements

As staff prepares to initiate project implementation strategies relative to large scale capital improvements associated with the recent voter referendum general obligation bond approvals, we've been able to determine that the City of Delray Beach is able to leverage bond proceeds with project funding that is currently available via the Resilient Florida Grant Program.

As the City of Delray Beach has recently achieved success in securing funds via this program, direction is being offered to pursue said opportunities to help more fully implement the Delray Beach Fire Rescue Facilities Master Plan. This will likewise include Fire Station 112 (to replace the building at the current site, involving no permanent relocation activity whatsoever), as well as other ancillary public safety enhancements.

Recommendations for City Commission approval for grant proposal submission as outlined will be offered via the June 6th regular meeting.

<u>Demolition of Temporary Classroom Units at Catherine Strong</u> <u>Park</u>

With the recent conversion of tennis courts into six permanent pickleball courts at Catherine Strong Park, the City of Delray Beach is currently experiencing a

sense of enthusiasm at this location.

Direction is currently underway to proceed with demolition of the adjoining temporary classroom units that were previously donated to the City of Delray Beach by the School District of Palm Beach County. The Department of Public Works has advised the Office of the City Manager that this task is anticipated to be completed during the next couple weeks.

The Department of Parks and Recreation will likewise begin planning activities necessary to install two additional pickleball courts at this site.

Calendar of Meetings, Activities, and Functions

An integral function of this past Wednesday's Executive Leadership Team meeting included a preparation dialogue relative to next week's annual goal setting session. This involved guidance and preparation to connect outcomes and expectations to the Fiscal Year 2023-2024 Proposed Budget process, as well as assurances that leaders of involved departments were able to have productive preliminary discussions with Facilitator Consultant Michelle Ferguson accordingly.

Given the May 12th annual goal setting event and the associated focus and preparation that will continue in the coming days, no information letter will be issued next week. Reporting as noted will therefore resume Friday, May 19th.


