PUBLIC NOTICE

RE: NE 14th STREET LAND USE MAP AMENDMENT

Pursuant to the Land Development Regulations of the City of Delray Beach, you are hereby notified that the **PLANNING AND ZONING BOARD**, acting as the Local Planning Agency, will conduct a **PUBLIC HEARING** on **MONDAY**, **JUNE 19**, **2023** at **5:01 PM** to consider and make a recommendation to the City Commission on Ordinance No. 27-23, a City-initiated Land Use Map Amendment (LUMA) from Low Density Residential (LD) to Open Space (OS) land use to correct a data conversion error on a parcel totaling 0.45 acress currently addressed as NE 14th Street (see map below).

The requested amendment from LD to OS for the subject property is related to a data conversion error recently identified by City Staff. In 2016, the City switched from utilizing AutoCAD to using Geographic Information Systems (GIS) for its mapping software; the land use designation of these parcels was inadvertently changed to OS from LD. However, the subject parcel has had an open space land use designation since 1989. Therefore, the proposed amendment corrects the mapping error by returning the designation of the parcels to OS.


