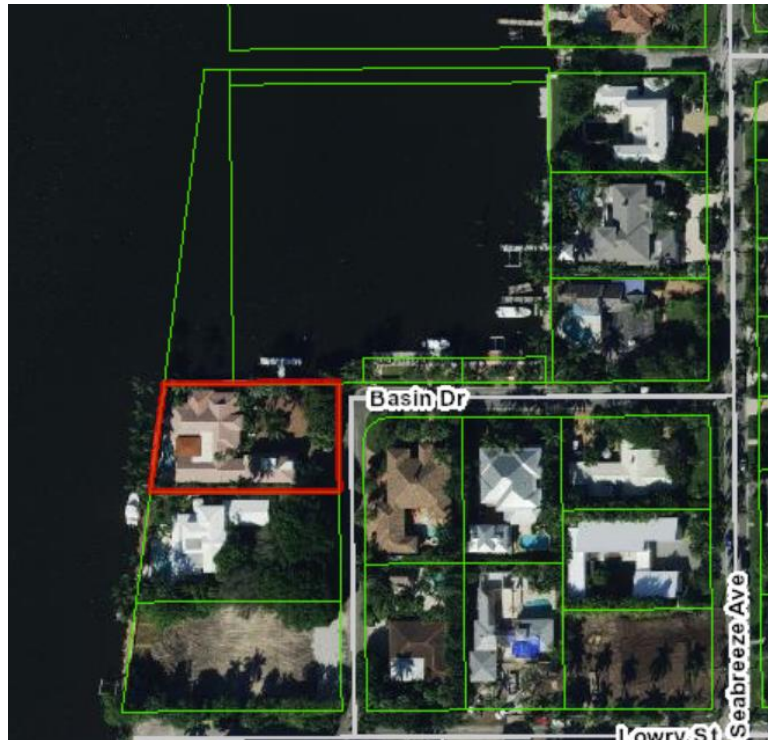
RE: REQUEST FOR A MODIFICATION OF THE STANDARDS FOR APPROVAL IN LAND DEVELOPMENT REGULATION (LDR) SECTION 7.9.11 “BOAT LIFTS”, TO PERMIT A BOATLIFT IN THE RAISED POSITION TO EXTEND MORE THAN 20 FEET INTO THE WATERWAY FOR THE PROPERTY LOCATED AT 112 BASIN DRIVE.

Pursuant to the Land Development Regulations (LDR) of the City of Delray Beach, you are hereby notified that the **CITY COMMISSION** will conduct a **Quasi-Judicial Hearing** for the purpose of accepting public testimony regarding “**112 Basin Drive,**” for a request for a modification to the standards for approval in Land Development Regulation (LDR) Section 7.9.11 “Boatliffts” (Resolution No. 114-23). This notice is being provided as your property is located within 500 feet of the subject property.

The meeting will be held on **Tuesday, July 18, 2023, at 4:00 PM**, or as soon thereafter, in the Commission Chambers at City Hall, 100 N.W. 1st Avenue, Delray Beach, Florida. At this meeting, the City Commission will consider a request to permit a boat lift in a raised position to extend more than 20 feet into the waterway. LDR Section 7.9.11(A), “Boatliffts”: state that a boat lift may extend into the waterway no more than 20 feet from the property line, seawall, or bulkhead, whichever is nearer to the waterway. The request is to extend the boat lift 39 feet 2 inches.
