## Abandonment of a Portion of Dixie Highway Right-of-Way, Adjacent to 2410 North Federal Highway (File No. 2023-161)

Pursuant to the Land Development Regulations of the City of Delray Beach, you are hereby notified that the **PLANNING AND ZONING BOARD**, acting as the Local Planning Agency, will conduct a **PUBLIC HEARING** on **MONDAY**, **AUGUST 21**, 2023 at **5:01 PM** to consider and make a recommendation to the City Commission on the Abandonment of a portion of Dixie Highway Right-of-Way, adjacent to 2410 North Federal Highway (map below).

The request is for the abandonment of City-owned right-of-way consisting of a 20-foot-wide strip of Old Dixie Highway adjacent to Lots 9 and 10 of the Plat of Delray Beach Estates, Plat Book 21, Page 13 of the Official Records of Palm Beach County, Florida. The subject area is approximately 4,049.6 square feet.

The right-of-way under consideration is adjacent to 2410 North Federal Highway, which is zoned General Commercial (GC) with land use General Commercial (GC).

In the event that the abandonment request is granted, obligations may be incurred (i.e. additional land or additional property taxes) as the abandoned area will become part of Lots 9 and 10. If approved, the receiving property owners will be obligated to maintain and develop the area in accordance with the City of Delray Beach Code of Ordinances, Land Development Regulations, and any other applicable local, state, and federal regulations.


