**RE: MASTER DEVELOPMENT PLAN FOR DELRAY COMMONS AT 5024-5070 WEST ATLANTIC AVENUE**



Pursuant to the Land Development Regulations of the City of Delray Beach, you are hereby notified that the **PLANNING AND ZONING BOARD**, acting as the Local Planning Agency, will conduct a **PUBLIC HEARING** on **MONDAY, AUGUST 21, 2023 at 5:01 PM** to consider a Master Development Plan (MDP) modification with waivers for Delray Commons, located at 5024-5070 West Atlantic Avenue (map at left).

The request is associated with the addition of a 1,820 square-foot bank to Tract 2 (addressed as 5070 W. Atlantic Avenue) with associated waiver requests and MDP waiver requests with of perimeter buffers, minimum building size, lot coverage, and open space percentage requirements.
