Next Steps Regarding Golf Course Upgrades, Renovations, and Management Services Agreement Consideration Process

With the City of Delray Beach currently experiencing interest from external parties, via the recently initiated Request for Information process necessary to gage the marketplace for entities desirous of working with our organization to advance operations and management services at Delray Beach Municipal Golf Course, please be advised that direction is to soon be offered to secure additional information regarding specific proposal details.

As referenced in the attached electronic mail message, from both Purchasing Manager Peggy Cadeaux and the City's purchasing consultant Kirk Buffington, guidance as outlined will soon involve a responding Request for Proposal process, to likewise include specific management approaches for golf course operations and maintenance, as well as applicable cost and facility enhancement considerations.

With remaining solicitation activities to be administered during the coming weeks, specific recommendations for City Commission review and involvement will be offered soon thereafter.

Renewal of Blue Flag Beach Designation

Both the Office of the City Manager and that of Director of Public Works Missie Barletto are pleased to report that the City of Delray Beach has achieved the first step necessary to secure a second consecutive Blue Flag Beach Designation.

As noted in the attached electronic mail message from Ms. Barletto, outcomes to this effect are the result of continuous adherence to strict environmental monitoring standards, yielding formal recognition that our community's beach is one of safest in the world in terms of water quality and public safety.

Given progress as outlined, arrangements are being made to host an awards ceremony and presentation, to include hoisting a new "blue flag" to showcase recognition accordingly, Wednesday, May 8th.

Expansion of Downtown Recycling

With the recent selection of Ms. Mary Wozny to the position of Sanitation Administrator, the Department of Neighborhood and Community Services has since been able to work collaboratively with Waste Management and other partners to expand community recycling programming to benefit the downtown vicinity.

As noted in the attached electronic mail message, from Director of Neighborhood and Community Services Sam Walthour, arrangements to this effect included hosting stakeholder meetings with leadership of the Downtown Development Authority (DDA), the Chamber of Commerce, Waste Management, and the Solid Waste Authority of Palm Beach County (SWA) to achieve collaboration relative to strategic organization and outreach accordingly. This specifically involves individual business engagement to ascertain levels of interest for additional recycling services in the area, as well as cost effective logistics for respective collection and distributions activities.

The results of a recent DDA administered survey indicate that over 20 businesses are supportive of the expansion of downtown area recycling programs. Given this outcome, as well as SWA's commitment to work closely with the City of Delray Beach to help identify additional locations for recyclable cardboard collection, all involved hope to provide more recycling access as outlined within the next few months.

<u>United States Department of Justice Community Relations</u> <u>Service</u>

My office hosted a meeting yesterday afternoon with leadership of the Delray Beach Police Department and United States Department of Justice Conciliation Specialist Reginald Malden to discuss details of that agency's Community Relations Service (CRS) program.

As the mission of CRS is to provide facilitation, mediation, training, and consultation services that improve communities' abilities to problem solve and build capacity via opportunities that otherwise would not become available, invitations for future partnership as noted with local law enforcement agencies are currently being made available. For Delray Beach, this involves connecting with the CRS Southeastern Regional Field Office in Miami.

With the Police Department continuing to advance neighborhood and community outreach and applicable collaboration efforts, the Office of the Chief of Police is being empowered to consider engagement with CRS to potentially achieve ancillary assistance and support accordingly.

Calendar of Meetings, Activities, and Functions

Earlier this week, both Assistant City Manager Jeff Oris and I were given an opportunity to tour the real crime center operations, at the Delray Beach Police Department. This engagement afforded us an orientation relative to technical functionality, as well as effective outcomes relative to crime prevention and resolution that would otherwise not become possible.

The Office of the City Manager is supportive of this feature of law enforcement services, as our organization will now become more responsive relative to keeping Delray Beach safe and secure.

With next business week being abbreviated due to the President's Day holiday weekend, no information letter will be issued Friday, February 23rd. Weekly reporting as noted will likewise resume Friday, March 1st.

Blue Flag Beach Designation

Good Afternoon Terrence,

The City has recently received notification from the American Shore and Beach Preservation Association (ASBPA) that our 2024/2025 Blue Flag application was approved by the National Blue Flag Jury and has been moved along to the International Blue Flag Jury for review. We anticipate hearing back from the International Blue Flag jury about our application in April. In anticipation of the Blue Flag Award a second year, we have started organizing for this year's Blue Flag Award Ceremony, currently scheduled for May 8 @ 10AM. This event will be held at the A1A & Atlantic Flag Pole / Pavilion location and will be an opportunity for our City leaders and staff to celebrate the award receipt and hoist the new season's flag.

As you know, each Blue Flag award is given for only one year and a new application must be submitted for consideration each year. This is done to ensure that each beach flying the Blue Flag continues to maintain the high environmental and public safety standards that qualify the beach to be included in this prestigious listing. The Delray Municipal Beach was the first such award in the continental United States, sharing that distinction with a beach in California. Again this year, these are the only two beaches in the continental US that are being considered for Blue Flag designation. Beginning next week, our beach visitors will find that we have replaced the Blue Flag Beach information boards in the dune beside each pavilion with new digital information boards that will be installed inside each of the pavilions to avoid blocking the view of the ocean. The digital boards will provide continuous information about water quality and surf conditions, as well as a map of the beach and educational videos and other information.

In addition to the Blue Flag award event, the ASBPA Program Coordinator will be having her quarterly Blue Flag Interest meeting for other Florida beach managers and municipal leaders to attend and learn more about the Blue Flag Award at the Swinton Operations Center on May 7.

We are looking forward to our second year of Blue Flag designation and hope to be sharing that good news in April.

Expansion of Downtown Recycling

Mr. Manager,

Collaborative efforts are currently underway with Waste Management (WM) and community stakeholders to expand recycling opportunities in the downtown district. Mary Wozny, the new Sanitation Division Administrator and downtown recycling team lead for the department, has made significant progress as noted below:

- o Held downtown stakeholder meetings with the Downtown Development Authority (DDA), Delray Beach Chamber of Commerce, Solid Waste Authority (SWA) and WM.
- o The DDA distributed a survey to businesses with responses indicating an interest in recycling. Primary concerns are cost and space/logistics.
- o The DDA will provide SWA and the City with the contact information of businesses interested in recycling for targeted outreach.
- O Working with SWA to increase the number of public cardboard recycling drop off locations on City property. Right now, there are two (2) locations with a total of five (5) cardboard recycling dumpsters on City property and we are verifying additional locations for public use throughout the City that are on private property (businesses).

As increased access to recycling is realized in the months ahead, we will keep you posted.
