# Water Service Agreement Involving the Town of Gulf Stream

As the City of Delray Beach's long-term agreement to provide bulk portable water services to the Town of Gulf Stream formally expired in June 2023, please be advised that formal notification is being offered to discontinue services as outlined, effective June 17, 2025.

As referenced in the attached notification letter to Gulf Stream Town Manager Gregory Dunham, the initial pact involved a 25-year commitment, from 1998 to 2023.

With the City of Delray Beach's legal obligation to this effect having ended June 16, 2023, Gulf Stream has actually been on formal notice of our organization's intention to not renew as noted since May 2022. Above and beyond last year's aforementioned agreement conclusion, current and long-term water utility operational functions do not support service delivery to other municipalities.

Finally, given the March 5, 2024 agreement authorization to have CDM Smith to initiate design services for our community's new water treatment plant facility, future accompanying infrastructure and water resources need to likewise support current and future demand solely for the Delray Beach Corporate Limits.

# Guidance and Direction Concerning Atlantic Avenue Historic District Designation

With pending commitments and direction to consider the formal establishment of the Atlantic Avenue Historic District, my office hosted a meeting two days ago with involved staff to discuss remaining logistics to support guidance accordingly.

As referenced in the attached electronic mail message from Director of Development Services Anthea Gianniotes, modifications to the property survey

instrument necessary to structure the district will soon be experienced. Such is also a function of staff currently evaluating if any recent modifications to, or changes in ownership of, the properties in the proposed district have occurred.

With respective consultancy services now being approved by the Office of the City Manager, necessary updates to the survey are anticipated to be finalized during the next couple of months. Arrangements for a follow-up City Commission presentation of outcomes accordingly are therefore anticipated via the August 13<sup>th</sup> workshop meeting. Once this is achieved, first and second readings for an ordinance to adopt the district will be scheduled.

# Education Board Proposed Goals and Initiatives for Program Year 2024-2025

With the Delray Beach Education Board having recently assembled its proposed initiatives summary for Program Year 2024-2025, please be advised that arrangements are being made to formally request that the City Commission evaluate as noted for review and consideration.

As referenced in the attached outline to this effect, opportunities include developing relationships with community partners and educational stakeholders to help target academic proficiency to ultimately improve reading, math, and behavioral performance amongst students enrolled in Delray Beach Public Schools. Direction to this effect may likewise involve collaboration with existing after school and summer camp programs (via ancillary involvement from the School District of Palm Beach County) to incorporate additional academic remediation programming accordingly.

Arrangements are likewise being made to host a brief presentation as noted during the June 4<sup>th</sup> regular City Commission meeting. Education Board Chair Dr. Raiko Knight will therefore facilitate the dialogue on behalf of her colleagues.

#### RE: Water Service Agreement Between the City of Delray Beach and the Town of Gulf Stream

Mr. Dunham:

This letter serves to provide the Town of Gulf Stream ("Town") with formal notice of the City of Delray Beach's ("City") intention to discontinue water service effective June 17, 2025.

The Town and the City entered into an Agreement for Water Service on June 17, 1998 ("Agreement") for a term of twenty-five (25) years. The Agreement required the City, during the effective period of the contract, to provide all water necessary to fulfill the requirements of the Town. The City's legal obligation ended on June 16, 2023.

The Town has been on formal notice of the City's intention not to renew the Agreement since May of 2022, if not before. Despite the City's repeated forewarnings to the Town, the Town has refused to acknowledge the City's position and has intentionally failed to take action on behalf of its residents. The City held numerous meetings with the Town in anticipation of the expiration of the Agreement and, in fact, offered a two-year extension of the Agreement which the Town declined to execute. Indeed, the City has no other option but to issue this Notice.

Therefore, at 11:59 p.m. on June 16, 2025, the City of Delray Beach will formally terminate its relationship with the Town by disconnecting all connection facilities servicing the Town. The City remains committed to assisting the Town in this matter amicably, and looks forward to the Town's anticipated cooperation.

    - o Delray Beach Library
    - o Local Churches
    - o Private, local businesses
- 3. Develop Education and Workforce Development Roundtable to serve as a centralized body reporting to the City Commission coordinated efforts to advance education in Delray Beach
  - **Objective 1:** Develop a collaborative body of appointed stakeholders, including representatives from School District of Palm Beach County, Delray Beach educators and school leaders, Delray Beach students and parents, representatives from local colleges/universities, representatives

from local businesses, and elected officials, to discuss the state of education and workforce in Delray Beach

- **Objective 1**: Identify and apply for federal, state, and private grants to fund educational programing. Adult Ed
- 6. Support Adult Education Programming, pre-apprenticeships, apprenticeships, and workforce integration.
