## PUBLIC NOTICE

## RE: Abandonment of Alley Right-of-Way, bisecting 2001 South Federal Highway (File No. 2024-052)

Pursuant to the Land Development Regulations of the City of Delray Beach, you are hereby notified that the **PLANNING AND ZONING BOARD**, acting as the Local Planning Agency, will conduct a **PUBLIC HEARING** on **MONDAY**, **May 20**, **2024** at 5:01 **PM** to consider and make a recommendation to the City Commission on the Abandonment of an Alley Right-of-Way, bisecting 2001 South Federal Highway (map below).

The request is for the abandonment of City-owned right-of-way consisting of a 20-foot-wide alley adjacent to Tract B of the Plat of Gateway Shopping Center, Plat Book 25, Page 76 of the Official Records of Palm Beach County, Florida. The subject area is approximately 5,302 square feet.

The right-of-way under consideration is adjacent to 2001 South Federal Highway, which is zoned Automotive Commercial (AC) with land use General Commercial (GC).

In the event that the abandonment request is granted, obligations may be incurred (i.e. additional land or additional property taxes) as the abandoned area will become part of Tract B. If approved, the receiving property owners will be obligated to maintain and develop the area in accordance with the City of Delray Beach Code of Ordinances, Land Development Regulations, and any other applicable local, state, and federal regulations.
