# **Trajectory for Golf Course Renovation Program Design Process**

In response to direction offered during the May 3<sup>rd</sup> annual goal setting exercise, relative to considerations to advance the Delray Beach Municipal Golf Course Renovation Program, leadership from the Office of the City Manager, the Department of Parks and Recreation, and the Department of Public Works have all since determined that the most expedient option for completing necessary design services involves contracting with Sanford Ferris Golf Design to reengage the professional services contract that was first initiated early Fiscal Year 2020-2021.

As referenced in the attached electronic mail message from Sanford Ferris Principal John Sanford, the City of Delray Beach can proceed as outlined beginning in the coming weeks. However, given the associated price tag of approximately \$1.75 million, budget adjustment considerations to proceed with respective contractual services will be necessary.

Arrangements to offer formal recommendations for City Commission review and evaluation are therefore now being planned for the July 9<sup>th</sup> regular meeting. Likewise, if approval to proceed as outlined is granted, resulting design outcomes are expected to be achieved in Fiscal Year 2024-2025, enabling construction implementation, circa Fiscal Year 2025-2026.

# <u>Timeline for Parks General Obligation Bond Issuance and</u> <u>Transactions</u>

As directed and committed during last week's workshop meeting, relative to the current trajectory for initial park improvement programming, via the associated 2023 General Obligation Bond referendum, please be advised that necessary transaction processes were successfully directed a few days ago. to this effect will likewise now enable the City of Delray Beach to timely prepare for the respective Fiscal Year 2024-2025 budget cycle.

As referenced in the attached Summary Notice of Sale, guidance to this effect involves the administration of bids for the sale of \$9.1 million in principle amounts. The difference between this figure and the previously discussed \$10 million commitment involves the contemplation that bonds will sale at a premium. Once this is achieved, a remaining amount to the City of Delray Beach is anticipated accordingly.

Likewise, with the resulting transaction anticipated to close late next month, initial tasks for project implementation activities (in addition to a June 4<sup>th</sup> City Commission meeting update relative to plans for external public engagement for parks improvement programming and implementation) are to be executed soon thereafter.

# Interstate 95 Ramps/Interchange Landscaping and Litter Removal Collaboration Involving the Florida Department of Transportation

In response to unsightly observations relative to both litter and landscaping conditions that have continuously been experienced along Interstate 95 entrance and exit ramps in Delray Beach, please be advised that clarity was recently achieved relative to collaborative responsibilities involving the Department of Parks and Recreation and the Florida Department of Transportation (FDOT).

As referenced in the attached electronic mail message exchange between Director of Neighborhood and Community Services Sam Walthour and Sanitation Administrator Mary Wozny, a formal agreement to this effect likewise involves a 25-year pact that was reached with FDOT in 2012. However, this arrangement formally supports that FDOT will be primarily responsible for upkeep accordingly in areas that are most problematic in these regards.

While the Department of Parks and Recreation oversees maintenance activities for ramp areas that are located closest to City of Delray Beach thoroughfares,

FDOT continues to remain largely responsible for upward areas of the ramps, including catch basins that are located in respective immediate vicinities.

As a site inspection was conducted by both FDOT and City of Delray Beach team members to help highlight concerns and observations noted, all involved are now looking forward to a more consistent schedule of routine maintenance, attention, and care from FDOT.

# Reorganization of Education and Workforce Coordinator Position

In an effort to expand operational effectiveness and efficiencies relative to external engagement and community outreach, please be advised that direction is presently being offered to update the current education and workforce coordinator position for this purpose.

As referenced in the attached electronic mail message from Assistant City Manager Jeff Oris, guidance to this effect involves formally reorganizing the position to that of Education and External Opportunities Manager.

In addition to responsibilities concerning education-related policy matters involving both the School District of Palm Beach County and the Delray Beach Education Board, this role will also support ancillary community focus such as point-of-contact for community grant opportunities, as well as ancillary partnerships involving the City of Delray Beach that may otherwise not become available or possible.

As current position incumbent Janai Bowens was notified of direction as outlined yesterday morning, this restructuring will become effective Monday, June 3<sup>rd</sup>. Likewise, the Office of the City Manager very much looks forward to additional opportunities to expand the City's community liaison footprint as a result of executing leadership as noted.

Thank you for contacting Sanford Ferris Golf Design regarding the City of Delray Beach's public golf course.

In response to your request for a placeholder estimate for design, construction document and construction administration fees we offer the following information.

The estimated fees are based on the following items.

Fully utilizing the completed documents.

Completing the services according to the original scope of services minus wells and off site water main. Construction phase services are included for the golf course.

We have not discussed estimated fees with the sub consultants, therefore the fees are subject to change upon finalizing the scope of services, schedule and review by sub consultants for completion of the project. It is understood by both the City of Delray Beach and SFGD that the estimated fees are simply a placeholder for budgetary purposes and are subject to change upon finalizing the scope of services, project schedule and review by other consulting firms performing the work.

Major project components included in the fee estimate (placeholder) include project management, golf course, irrigation system, maintenance facility, on course restrooms, landscape, parking lot, on site water main, and bridges.

The estimated fee for the above services is \$1,750,000.00 and is subject to change as described above.

In accordance with the Official Notice of Sale all bids for the Series 2024 Bonds must be submitted electronically via Parity<sup>®</sup> by 11:00 a.m., Eastern Daylight Time on June <u>65</u>, 2024.

To bid, bidders must be a contracted customer of the IHS Markit's Parity/BiDCOMP Competitive Bidding System (the "System" or "Parity<sup>®</sup>"). Prospective bidders that do not have a contract with the System should call (212) 849-5021 to become a customer and to obtain a list of the bidding rules and procedures. As will be described in the Official Notice of Sale, the Series 2024 Bonds are being issued for the capital projects relating to certain improvements to certain City-owned parks, and (2) pay the costs of issuance of the Series 2024 Bonds.

The Series 2024 Bonds will be issued in fully registered book-entry-only form through the facilities of The Depository Trust Company, New York, New York, as the securities depository. Beneficial interests in the Series 2024 Bonds may be sold in denominations of \$5,000 or integral multiples of \$5,000. 

Attached is the executed agreement between FDOT and the City.

- The agreement was executed in 2012 and is in effect for 25 years.
- The City (referred to as the Agency in the agreement) agrees to maintain the landscape improvements in the areas highlighted in Exhibit A:

Maintenance includes: "Such maintenance to be provided by the AGENCY is specifically set out as follows: to maintain, which means to properly water and fertilize all plants; to keep them as free as practicable from disease and harmful insects; to properly mulch the planting beds; to keep the premises free of weeds; to mow the turf to the proper height; to properly prune all plants which at a minimum includes: (1) removing dead or diseased parts of plants, (2) pruning such parts thereof to provide clear visibility to signage and permitted outdoor advertising signs (per Florida Statute 479.106), and for those using the roadway and/or sidewalk; (3) preventing any other potential roadway hazards... To maintain also means to keep the hardscape areas clean, free from weeds and to repair said hardscape as

is necessary to prevent a safety hazard. To maintain also means to keep litter removed from the median and areas outside the travel way to the right of way line."

• The maintenance plan is described in detail in Exhibit C.

#### Mr. Moore;

Several months ago, the City Commission expressed an interest in having a staff person dedicated to distributing and overseeing the grants and other funding the City provides to our external partners. Such funding might include that given to the non-profits that occupy City-owned (or leased) facilities such as Sandoway House, the Spady Museum, the Delray Beach Public Library, or funds recently lined up for our local schools, and other such current and future external funding opportunities as the City may take advantage of in the future such as additional funding opportunities as well as other multi-organizational collaborations that may help all of us accomplish positive outcomes for the residents of Delray Beach with minimal if any additional inputs by the City or partner organizations.

After a review of the workload for a person to be administering and overseeing such funding it was found that the hours necessary were not significant enough to warrant a full-time employee for this role. Many oversight mechanisms are already in place and thus it is not anticipated that future funding to partners will require a large amount of person-hours to oversee. The most labor-intensive portion of this ask is for someone who can devote additional time to interacting with current and potential local partners to explore mutually beneficial opportunities that otherwise would not be realized.

Given this information and several conversations you and I have had leading to this point in time, I would recommend that we upgrade the position of Education and Workforce Development Coordinator to encompass the new responsibilities of oversight of our funding of external partners and seeking new, productive collaborations that benefits the Delray Beach community. I would suggest a more descriptive title to the position, Education and External Opportunities Manager that is encompassing of the job responsibilities and conveys a positive movement. The current incumbent in the Education and Workforce Development Coordinator position, Ms. Janai Bowens has shown that she is fully capable of taking on these additional responsibilities and in her current position she interfaces with many of the external organizations (both current partners and potential future partners) with whom the new position will have to interact.

If you agree with this direction, I can begin to work with the Human Resources Department to implement the reorganization of the Education and Workforce Development Coordinator position into the Education and External Opportunities Manager position immediately.
