### **RULES AND REGULATIONS**

The “505” Teen Center is a Drop-in facility for all Delray Beach youth grades 6-12 or up to the age of 20 years old. The center is committed to provide entertaining alternatives in an alcohol and drug free environment. The “505” Teen Center is a drug and alcohol free facility. Anyone inside the facility under the influence and or wearing paraphernalia of any illegal substance will be removed from the facility. Activities that are illegal, immoral or unethical will not be permitted. This includes: offensive language & clothing, fighting, weapons, harassment, drugs, alcohol, gambling/dice and hats/sandals.

The “505” Teen Center expects all teens to follow the center’s rules and regulations. Teens are expected to uphold the behavior of young adults when in the facility AND when participating in outside Teen Center events.

The following will result in suspension from equipment use and/or the facility: a) failure to adhere to the center’s rules and regulations b) being disrespectful towards staff and/or peers c) any misuse of equipment d) Lack of respect towards staff, including talking back and/or improper language. Teen Center staff and supervisor determine length of suspension, and a follow up call will be made to the parent/guardian if deemed necessary.

The Teen Center shows movies rated PG-13 and cable programming such as MTV. Please be advised that NO rated R movies are previewed. The Teen Center goes on frequent field trips year-round. Permission slips must be signed for EACH field trip, and will be available one week before each scheduled trip.

A picture will be taken for identification purposes and it will be filed at the “505” Teen Center. The application and picture must be completed in order to participate in events, attend field trips, sign out sports equipment and video games at the “505” Teen Center.

**School ID, Report Card or Birth Certificate are required at time of registration. Proof of Residence is required also.**

At various times, the City of Delray Beach videotapes and photographs events to be submitted to the local media. By being a member with the “505” Teen Center & Hobbit Skate Park, I/we hereby authorize the City of Delray Beach to reproduce, copy, exhibit, publish, broadcast or distribute any and all such tapes or photographs.

CITY OF DELRAY BEACH "505" CONSENT WAIVER FOR MINORS

In consideration of my minor child/ward ("my child") (as set forth on the previous page), being allowed to use the Delray Beach "505" Teen Center, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury to my child from the use of the Delray Beach "505" Teen Center is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist; and **FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown, and assume full responsibility for my child's participation; and
2. I willingly agree to comply with the Rules and Regulations of the "505" Teen Center and I hereby acknowledge that myself and my child have received a copy of the Rules and Regulations and I shall ensure that my child will follow and adhere to them; and

I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE THE CITY OF DELRAY BEACH, AND HEREBY INDEMNIFY AND HOLD HARMLESS** its officers, officials, agents, representatives, and/or employees. ("Releases") **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH**, or loss or damage to person or property incident to my child's use of the Delray Beach "505" Teen Center, **WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest extent permitted by law. (Nothing contained herein is intended nor shall be construed to waive the City of Delray Beach's rights and immunities under the common law or Section 768.28, Florida Statutes, as amended from time to time.)
4. By signing this document, I understand that I am hereby releasing the City of Delray Beach from any and all liability for my child's use of the Delray Beach "505" Teen Center in accordance with Florida Statutes §316.0085(3)©.

## **TEEN CENTER RULES & REGULATIONS**

1. All Teens must register at the 505 Teen Center BEFORE using the facilities for the year.
2. The teen center is open to registered teens only. The hours of operation are Monday – Friday from 3pm to 9pm; Saturdays from 12pm to 9pm and Sundays we are closed. Summer and holiday hours will be posted.
3. Teen Center is for grades 6-12 and up to the age of 20. Applications MUST be signed by their parents or legal guardians, and the waiver must be notarized before entering the teen center for the first time. The applications are available on our website ([www.mydelraybeach.com](http://www.mydelraybeach.com)) or at the “505” Teen Center. Proof of grade/age will be required.
4. Anyone under the age of 12 or have not reached the 6<sup>th</sup> grade will not be allowed in the Teen Center.
5. There will be NO alcohol, drugs, and drug paraphernalia of any kind allowed in the building or on City Property. This includes clothing, hats, backpacks, etc.
6. You must have your pants pulled up to waist level. Baggy pants will not be tolerated.
7. No gambling or dice playing in the building or on city property.
8. No weapons of any kind will be allowed inside the building or on city property.
9. Absolutely NO FIGHTING. Removal of both parties and discipline actions will follow.
10. No horse playing and/or throwing of the football or basketball is allowed inside the building.
11. You must clean up after yourself. All trash must be thrown out in the garbage cans.
12. Promptly report any observed damage to the teen center to the 505 Teen Center staff at (561) 243-7158
13. Reckless/Improper behavior, talking back to staff or abusive/profane language will not be tolerated at all. Discipline actions will follow.
14. Due to safety concerns, spectators must remain outside of the fenced-in skate park area.
15. Once you reach the age of 20, your membership has expired and you will not be allowed to use the facility anymore.
16. The City of Delray Beach reserves the right to close the teen center at any time in the event of inclement weather, damaged facilities or other unsafe conditions.
17. Teen Center members not observing the above noted Rules & Regulations may be asked to leave the facility and may lose their membership privileges for a prescribed period of time.
