PUBLIC NOTICE: DEMOLITION AND VARIANCE

Pursuant to the Land Development Regulations (LDR) of the City of Delray Beach, you are hereby notified that the HISTORIC PRESERVATION BOARD, will conduct a PUBLIC HEARING on WEDNESDAY, SEPTEMBER 4, 2024, at 6:00 PM (or at any continuation of such meeting set by the board), to consider an after the fact demolition and variance request for the property located at 202 North Swinton Avenue, within the Old School Square Historic District.

The after the fact demolition request is associated with a one-story contributing detached accessory structure and is being processed in accordance with LDR Section 4.5.1(F).

The variance request, a result of the after the fact demolition request, is associated with an addition to the accessory structure. The request is to reduce the minimum required rear (west) setback, pursuant to LDR Section 4.3.4(K), from 10 feet to 3 feet.

All interested parties are invited to attend the public hearing, any member of the public wishing to comment publicly on any matter, including public comment or public hearing items, may comment inperson during the presentation of the item in the City Commission Chambers at 100 NW 1st Avenue, Delray Beach, FL 33444, or submit their comments in writing to the Development Services Department by e-mail to
