LANGUAGE ACCESS PLAN

2021 Limited English Proficiency (LEP) Plan for the City of Delray Beach

BACKGROUND

1. City Policy: Nondiscrimination Policy (GA-25, Rev.0)

The City of Delray Beach will not exclude from participation in, deny the benefits of, or subject to discrimination anyone on the grounds of race, color, national origin, sex, age, disability, religion, or family status.

2. Who is an LEP person?

Limited English Proficiency is used in reference to an individual who is not proficient in the English Language.

3. Title VI of the Civil Rights Act of 1964, Executive Order 13166

Requires recipients receiving federal funding to examine their services and programs provided, to implement systems that provide meaningful access to persons with limited English proficiency. These services will be provided to the extent that funding permits based on the law and City regulation.

4. Intent of the plan: To ensure access to information and services to LEP persons.

The intent of the LEP plan is to provide access to public notification, documents, and services for LEP individuals within the City of Delray Beach.

FOUR FACTOR ANALYSIS

To provide meaningful access and determine extent to which services will be required, the City requires the four-factor analysis.

Factor 1. Number or proportion of persons in eligible areas in need of service by the City's program and services.

The City will monitor the LEP population annually to determine the number of persons served as well as those who need to be served.

To determine the percentage of LEP individuals within our eligible service area, the City of Delray Beach reviews data provided by the United States Census Bureau.

Within the City of Delray Beach, an estimated 30.4% of the population speak a language other than English. Of the total 30.4% non-English speakers, 28.8% are Spanish speaking residents. According to the Census Bureau the most common birthplaces for foreign-born residents of Florida are Cuba, Haiti, and Columbia. This is indicative of the LEP residents that are mainly assisted which speak Spanish or Creole.

> Factor 2. The frequency with which LEP persons come in contact with the program.

Data will be collected annually with the amount of assistance that may need to or have been provided to LEP individuals. The City data collected will include the number of requests for translation and interpretation of City documents, programs and activities.

Factor 3. Importance of the program and service provided.

It is important that Limited English Proficiency (LEP) residents have access to information and services provided. The City will continue to develop and update the program to provide equal opportunity for LEP individuals and most commonly used languages.

Factor 4. The resources available to LEP recipients and cost of services.

Presently, the City of Delray Beach provides Spanish and Creole translated material which are completed by City Staff. LEP individuals who call in or visit City hall can request the assistance of a Spanish or Creole speaking City staff.

Identifying the estimated LEP population within City of Delray Beach based on the United States Census Bureau.

4. Translating written documents

The City currently translates documents into Spanish and Creole. The LEP Plan will identify the supply and language interpretations needed.
