THE FOLLOWING ADDRESSES ARE AFFECTED BY THIS PRECAUTIONARY BOIL WATER NOTICE:

925-960 Greensward Lane

THE CITY OF DELRAY BEACH WATER SERVICE WILL BE TEMPORARILY INTERRUPTED DUE TO A WATER MAIN RELOCATION AT OR NEAR YOUR LOCATION ON THURSDAY, SEPTEMBER 09, 2021. SERVICE WILL BE INTERRUPTED FROM APPROXIMATELY 9:00 AM UNTIL 11:00 AM.

THEREFORE, AS A PRECAUTION, WE ADVISE THAT ALL WATER USED FOR DRINKING AND COOKING BE BOILED. A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT AND AS AN ALTERNATIVE BOTTLED WATER MAY BE USED.

THIS DOES NOT INDICATE THAT THERE IS BACTERIA PRESENT IN THE WATER, HOWEVER WHEN A SERVICE INTERRUPTION OCCURS AND PRESSURE IS REDUCED BELOW 20 PSI, IT IS REQUIRED BY FEDERAL, STATE, AND LOCAL AUTHORITIES TO ISSUE A BOIL WATER ORDER. WE APOLOGIZE FOR ANY INCONVENIENCE THIS MAY CAUSE AND YOUR COOPERATION IS GREATLY APPRECIATED.

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK AND WHEN YOU RECEIVE A RESCISSION NOTICE.
